PROJECT DESCRIPTION/Objectives:

Background:

Two years ago the textile and clothing factories in Gaza have been allowed to market their products abroad. Gazan factories have not been permitted to do so for eight years, which led to undermining one of the Strip's most productive sectors.

Before the imposed siege on the Gaza Strip in 2000, the textile and clothing industry played an important role in the Palestinian economy, especially in the Gazan economy. This industry employed more than 36 thousand workers in 900 factories and tailor shops and delivered 1500 monthly shipments abroad. This huge industry decreased over the past 15 years. Currently, it only employs 4000 workers, and has 140 factories.

Nowadays, the factories owners and workers in the field expressed their optimism and expectations of the revival of the industry, which is almost dead due to the blockade.

Gazan clothing industry has a good reputation; the products have proven their ability to compete in the market. This is observed by the great demand on these products among traders, even though they varied options of products to import. The quality and competitive prices of the Gazan products have convinced the traders and the customers.

The exportation has helped in somewhat reviving the clothing industry in Gaza, and if things go as expected, the clothing and textile industry in Gaza will be revived again, but there are still some technical obstacles standing in the way such as:

- Absence of local fashion designers in the market forcing garment factories to rely on poor and outdated designs that don't meet consumers' preferences.
- Inability to bring in computer aided production machines into Gaza, which would create a faster production process, provide high quality production and reduce time and effort.
- Lack of skilled people, technician and graduates, a skills shortage at all levels.
- The training available from HEIs in the garment industry is neither marketresponsive nor industry-driven.

The Centre of Excellence (FACE) is a model of an industry-driven training and support service that aims to meet the sector's labour force needs. The initiative seeks to increase both the employability and wages.

Main Objective:

The project aims to strengthen the garment sector (Fashion Design and Dress Making), and equipping this sector in Gaza Strip by qualified workers related to market needs by establishment of Fashion Academy to be as a hub or center of Excellence for transition from University to Business, and for incubating the business ideas in the field of fashion design, pattern and dress making and the related fields.

Intermediate Objectives/Project Purpose:

1. Identifying the gap between the market and community needs and the output of HEIs in partner countries.



- 2. Capacity building of HEIs from Palestinian partners in the field of fashion design and dress making
- **3.** Curriculum and teaching methodologies.
- **4.** Improve & develop the target groups skills, Enhance the availability of qualified graduates to respond to the needs of the labour market.
- **5.** Developing competences, technical and soft Skills of staff, technicians and employees and enrich the experience of the workers in the field.
- **6.** Improve the TVET and the image of this type of professions in local community.

Activities

The Activities will be divided in five packages as described in Erasmus Forms, which are: Preparation, Development, Quality Plan, Dissemination & Exploration and Management, the following is a sample of activities which will be developed during the perpetration stage of the proposal:

- 1. Needs assessment phase.
- 2. Establishment of a FACE center
- 3. Development of guidelines, training and teaching materials including the innovative teaching methods and evaluation techniques;
- 4. Updating and developing short term and long term training programs to be related to market needs
- 5. Development of strategic plan of FACE and annual operational plan
- 6. Conduct the training programs for staff and technician and employees on new technologies, fashion and pattern design, Training of trainers, etc.
- 7. Development and coordination of the plan of action on quality control of the project implementation
- 8. Development and dissemination of project materials

Expected Results/Outcomes

- 1. The FACE Center is functional as coordinator for services and key players.
 - a. It has the capacity to implement Employer Based Training as an effective model.
 - b. Training providers deliver consistent, pre-employment and industry-oriented training with strong assessment certification capacities
- **2.** Needs assessment study with methodological material, new statistics and reports (data) that reflect the actual needs in this field.
- 3. Improved training and employment outcomes for women and neglected groups
- **4.** New and Upgraded Curriculum and learning / teaching resources
- **5.** Availability of qualified target groups (graduates, trainers, teachers, and management / administration staff) with improved and new skills.
- **6.** Active and operational Website for FACE center
- **7.** Raised Awareness and culture in garment industry sector from society & Better relation and networking with private sector.
- **8.** A system for interfacing / Liaisoning with private sector, business and industry, set up and operational
