Historical Establishment

Al-Quds Open University (QOU) is an administratively, academically and financially independent public University. In 1975, the requirement of the Palestinians for higher education in accordance with their demographic, social and economic situation under the Israeli occupation generated the idea of establishing a university that would match the needs of the local community. Consequently, upon the request of the Palestinian Liberation Organization, UNESCO conducted a feasibility study in 1980 to initiate with the project. The study was later approved by UNESCO General Conference and later by the Palestinian National Council in 1981, but the execution of the project was delayed until 1985 due to the Israeli invasion of Lebanon.

In 1985, a temporary headquarter in Amman was founded with the approval of the Jordanian Ministry of Foreign Affairs. From 1985 till 1991, the efforts were focused on preparing comprehensive study plans for different academic specializations, faculties, and the production of educational materials such as textbooks and teaching aids (mainly audio and visual ones).

After designing the academic programs, the university commenced its educational services at its new headquarter in Ramallah in 1991, and gradually introduced branches in major Palestinian cities. The number of enrolled students began with hundreds, and annually increased to reach 56,000 students by the end of the first semester of the Academic Year 2016/2017. The first graduates of the University received their certificates in 1997.

The University faced two major challenging events while laying its foundation. First, the first Intifada (civil uprising) in 1987 in response to the Israeli occupation. Second, the First Gulf War and its destructive economic and political consequences on the Palestinian society. However, the University continued to adhere to its principles and mission, inspired by the strong will of its previous leaders, to ensure that the University will always remain a vital source of education. The University later faced another challenge which is the second Intifada in 2000. Due to the unstable political situation at the time, students were not able to access universities outside their cities, so the number of enrolled students at the University doubled which reinforced the role of the University in disseminating education using open learning approach.

The University sought and is still seeking to spread open learning and E-learning in particular, not only in Palestine, but also in the entire Arab world to access larger number of beneficiaries,

students, trainees, and those seeking knowledge and education. The University is keen on promoting freedom of thought, opinion, creativity, innovation and excellence.

Overview

Al-Quds Open University (QOU) is the only academic institution in Palestine which has been intensively implementing all modes of e-Learning into its teaching and learning practices. QOU adopts the open learning approach for its educational policy and blended learning approach. Consequently, it combines between traditional classrooms and virtual classes. It is one of the largest universities in Palestine having a student body of more than fifty six thousands students in eight academic programs distributed across 18 branches in West Bank and Gaza. Over the past years, QOU mainly managed its academic programs through Moodle, a Course Management System (CMS), also known as a Virtual Learning Environment. The open source and community-based learning tools enable the management of student's online activities for several courses, which begin with learning practices and ends with assessments and evaluation of students work. Furthermore, QOU uses Learning Management System (LMS) platform to offer several self-study online courses.

Presidency of the University

Prof. Younes Amr

The president of the University -in coordination with the Board of Trustees- is responsible for managing the academic, administrative and financial affairs in accordance with the bylaws and regulations of the University. Furthermore, the president chairs the University Council and forms various specialized committees to manage the different affairs of the University. Moreover, the

president represents the University at local and international agencies and organizations in regards of various academic matters.

Other tasks include coordination of the president and his staff with the various departments and centers to manage and monitor the daily operations of the University. Furthermore, the president is responsible for the initiation and follow up of strategic development plans, and the supervision of the operations of the different branches with their faculties and departments.

Consequently, the president contributes in the achievement of the University's goals, alongside its vision and mission that aim towards continuous advancement in order to achieve excellence and leadership.

The current President of the University, Prof. Younis Amro holds a PhD in Arabic Language and Semitic languages. Prof. Amro had a long career in education and teaching, he has many publications and articles in the field of language, history, and literature. Prof. Amro occupied many academic, administrative, and public positions such as the chairman of the Palestinian Arabic Language Academy, the General Secretary and Head of Palestine Writers Union, and The Chairman of The Cultural Forum in Hebron. He is also a member of several public institutions such as the University Graduates Union in Hebron, the Board of Trustees of Al-liqa Center for Islamic and Christian Heritage Studies in Palestine, and the Board of Trustees at Alistiqual University, the Executive Council for Arab Universities Association, the Board of Trustees of the Union of Arabic Language Academies, and the Administrative Board of Palestine National School of Administration. He is also a cultural advisor for several cultural and intellectual journals and periodicals. Prof. Amro managed to obtain several awards, gold medals, certificates, and honorary awards for his accomplishments along the years in education.

International Awards:

- BID Award

- Ms. Hanan Al Hroub

Hanan Al Hroub is a graduate of Al-Quds Open University received a BA in Primary Education at the faculty of Educational Sciences. She was awarded, in 2016, the Global Teacher Prize, with a value of \$1,000,000. This Award is given to best teachers around the world. Hanan embraces the slogan 'No to Violence' and uses a specialist approach detailed in her book, 'We Play and Learn'. She focuses on developing trusting, respectful, honest and affectionate relationships with her students and emphasizes the importance of literacy. She encourages her students to work together, pays close attention to individual needs and rewards positive behaviour. Her approach has led to a decline in violent behaviour in schools where this is usually a frequent occurrence. She has inspired her colleagues to review the way they teach, their classroom management strategies and the sanctions they use.

- Dr. Laila Ghannam

Dr. Laila Ghannam is a graduate of QOU from the Faculty of Social and Family Development and holds a PhD in Psychology. She became the first female governor in Palestine in 2010. Dr. Ghannam began to serve in Fatah as a student and was quickly elected to its Ramallah council. Later she held a senior position with the organization's security forces, and then served as the welfare minister's head secretary. In 2010, she was appointed as the Governor of Ramallah and El-Bireh district. The position of governor carries a great deal of influence in the Palestinian Authority, as the governor is the figure of most seniority in each district, and appointed by the President of the state. Dr. Ghannam's tasks include heading the security forces operating within her jurisdiction and supervision over all municipality activities.

-Alecso Apps Award:

QOU received Alecso Apps Award in 2016 for designing smart devices application for students that contains lectures and educational material. The competition is **a**n annual challenge aiming to motivate and encourage Arab developers to meet high-level standards in term of Mobile Applications quality, innovation and Entrepreneurship.

- The Second Adventure and Challenge Championship for Arab Universities:

The University was awarded the first place in this championship that was organized by the Jordanian Ranger Adventure Camp under the patronage of the Secretary General of the Association of Arab Universities, Prof. Sultan Abu Orabi Al Odwan between 9-13/5/2012 in Jordan and again in 2013 winning the second place.

University Accomplishments

QOU's Administrative, academic and technical staff channels their efforts towards shaping the University as a pillar of education in the Palestinian society, and setting a platform for sustainable human development, self-reliance and independency. Following this philosophy, the University has been able to accumulate important achievements along the years since its establishment as follows:

-Academic Accomplishments

- Establishment of the faculty of Graduate Studies which offers two majors; Arabic language and literature, and Psychological and Educational Counseling.
- Establishment of a Media Faculty and an Art Faculty that offer Bachelor degrees in various fields.
- Adoption of blended learning approach (open learning combined with e-learning) for all the offered courses.
- Upgrading the content of some courses to be in the form of electronic educational packages.
- Adoption of Mobile Learning method (content can be taught and uploaded using smart devices for some courses.)
- Design of the first Arabic MOOC (Massive Open Online Course) in Palestine and the Arab World about the history of Jerusalem.
- Establishment of advanced labs for virtual libraries. The labs are equipped with computers, printers and smart screens according to the latest updates.
- Design of a comprehensive program for the management of QOU libraries.
- The Establishment of the Palestinian Center of Excellence in E-Learning for research and consultations, supervised by a national committee that represents most academic sectors in Palestine.
- Contribution in preparing and issuing the first Guide of Quality Assurance and Accreditation Standards in the Arab World in the field of Open Learning, with the cooperation of Association of Arab Universities.
- Development of a new BA program in Special Needs Education under the Faculty of Social and Family Development.
- Accreditation of a new Diploma program in Teacher Training by the Accreditation and Quality Assurance Commission and the Ministry of Education and Higher Education.
- Development of a new specialization in the field of Healthcare Management in several QOU branches.
- The continuous design and composition of new textbooks in various fields such as, Introduction to Public Health, Epidemiology, Financial Planning and Analysis, and many more.
- Establishment of a database for examinations in cooperation with ICTC.
- Establishment of a Mobile Educational Center (educational van) to improve educational
 opportunities in the marginalized areas in the South of Palestine equipped with computers,
 books and e-textbooks, which travels between schools and facilitate access to educational
 resources.

- Implementation of professional and technical trainings funded by international
 organizations such as Mercy Corps, GIZ, American Consulate, UNRWA to improve the
 capacities and skills of youths and public servants employees in IT, strategic planning in
 health and safety, administrative skills, teaching, and research development at schools and
 universities.
- Establishment of partnership projects with the local community (some in partnership with international institutions such as the Open University of Cyprus, UNOPS) in terms of awareness campaigns in relation to the importance of land protection and registration, home buyers awareness, introducing innovative learning practices to the educational system in Palestine, development of the internal capacity of the Palestinian Civil Police.

-Infrastructure Accomplishments

- Construction of new campuses across the state to facilitate access to education for all Palestinian communities.
- Horizontal and vertical expansion of the University to encompass the increasing rate of the enrolled students, and create supportive environment for open learning.
- Intensive fundraising efforts are carried out throughout the campuses to elevate the educational network of premises, centers, and facilities.

-Technological Accomplishments

- Development of various e-learning services and contribution in the improvement of eeducation in Palestine.
- Contribution in disseminating knowledge in the field of IT through organizing different events and projects.
- Development of the largest network of internet among the academic institutions in Palestine.
- Operating and hosting the EUMEDCONNECT which is an Internet network that is dedicated to create a high-capacity network for research and education communities. Besides operating the network, The University was responsible for expanding it to other educational institutions in Palestine till 2011.
- Establishment of three computer labs equipped with the latest IT developments specialized for students with visual disabilities to ensure their engagement in the learning process across Palestine, framing the north, center, and south (Jenin, Ramallah, and Hebron.)
- Establishment of three centers, ICTC, OLC and MPC for developing e-learning.
- Establishment of an integrated e-learning environment through utilizing computerized systems to manage all the learning procedures, in cooperation with ICTC, which plays a key role in managing and monitoring the e-learning process.
- Participation in Avicenna Knowledge Center, a project that engages a consortium of fifteen AVICENNA virtual Knowledge Centers (universities) to exchange experience and pedagogical innovation among Mediterranean and European universities in the field of open learning. Consequently, QOU established OLC to supervise the project in cooperation with ICTC. Moreover, QOU submitted a proposal to the UNESCO to disseminate the project to other Palestinian universities, and was later approved.

- QOU is the only university in Palestine to establish a multimedia center for producing multimedia educational materials (MPC). The center produces recorded lectures that utilize live streaming feature, in addition to documentaries in various fields, and a broadcast of QOU TV channel with its various educational programs.
- Organization of the World Cup in computing and internet, in which QOU obtained the fourth place in 2008 and 2009, and organizing the world champion in Microsoft Excel and Microsoft Word, in which QOU obtained the first place in 2008 and 2009. The events were organized by the University for three consecutive years (2007, 2008, and 2009).
- The addition of Palestine, with the effort of ICTC, to the list of certified countries by institutions worldwide that are specialized in IT such as Microsoft, Oracle, Sun Microsystems and Certiport, opening the doors for other Palestinian institutions to join as well. Furthermore, through obtaining membership at these IT institutions worldwide, has enabled QOU to hold international certified trainings and tests such as TOEFL and ICDL.
- Organization of QOU's "ICT day" annual event, initiated in 2005, which aims at promoting utilization of the latest updates of IT in the field of education, expanding the cooperation with international and local institutions specialized in IT, and disseminating knowledge in the field of IT to the local community.
- Launch of QOU educational TV Channel which broadcasts various materials in the aspects
 of health, education, sport, tourism and hospitality. The channel aims at raising the
 knowledge of the local community about different topics, promoting the blended learning
 approach, highlighting the social responsibility of the University, and cooperating with
 other Arabic and international institutions to encompass other cultures.
