Other relevant information	Kyrgyz State Law Academy (KSLA) is a specialized scientific innovative educational academy in the multi-level system of continuing training specialists with a higher legal education. The academy actively conducts researches in the field of law and other branches of knowledge. Different educational and scientific centres were created on the basis of the KSLA to offer full and part time internship for foreign students and

provide opportunities to conduct researches. Currently the following centres operates under KLSA are:

- Linguistic Centre that offers courses such as learning Kyrgyz, Russian and other languages
- Kyrgyz-Turkish Centre for Legal studies that works on improving laws in the field of legal regulations of the activities between Turkey and Kyrgyzstan, studying the law enforcement of Kyrgyzstan and Turkey, and providing legal support and consultation to people engaged in business and other activities in Kyrgyzstan.
- The Centre of the Eurasian Economic Union (EEU) was created to improve norms and regulations in the legal framework of Eurasian Economic Union in following areas:
- Violation of human rights in Eurasian Economic Union, including the lack of implementation of social guarantees like education, health care/ health insurance, pensions.
- Difficulties in the recognition of certificates obtained in the territory of one of the member states of EEU;
- Gender and ethnic discrimination in the workplace;
- Xenophobia and rice of intolerance;
- Plagiarism in education and academic field.
- Kyrgyz-Chinese Centre for scientific research and studies was created with support from Chinese embassy in Kyrgyzstan. This Centre aims at studying the issues of cooperation between China and Kyrgyzstan, at protecting the rights and legitimate interests of people engaged in business and other activities in Kyrgyzstan. Within the framework of this Centre, an International Conference on "Silk Road Economical Belt: Perspectives for the Central Asian economy" is scheduled to be held in September.
- The educational Centre of lawmaking was created with support from the USAID/DFID Programme in assistance to the Parliament of the Kyrgyz Republic – Jogorku Kenesh. The main activity of the Centre is directed to the conduction of intensive courses for training of Jogorku Kenesh, staff of the KR, KR Government Office staff, President of the KR, ministries and departments, representatives of public and business communities, who are involved in the lawmaking process. The educational Centre of lawmaking is created in purposes of improvement of quality for enactments and harmonization of rule-making activity in the Kyrgyz Republic through the developing of professional potential of members of the rule-making activity in the Kyrgyz Republic. Exchange students and academic staff can conduct researches in the field of law and benefit from the internship in the above mentioned centres. Moreover they can make contacts with governmental structures and have access to legislative information including bill numbers, public laws, private laws and so on.
